**DATES FOR REGISTRATION,
ENROLLMENT AND ABSENTEE BALLOTS

- Aug. 19** Last day for applications for registration/enrollment for the Primary Election to be postmarked. 5-210 (3)
- Aug. 24** Last day for “Change of Address” to reach the Board of Elections to be effective for the Primary Election. 5-208.3
- Sept. 6** Last day to apply by mail for absentee ballot for the Primary Election. 8-400(2c)
- Sept. 12** Last day to deliver absentee ballot application or apply in person for an absentee ballot for the Primary Election. 8-400(2c)
- Sept. 13** Absentee ballots for the Primary Election must reach the Board of Elections by the close of the polls on primary day EXCEPT ballots postmarked by the postal service not later than the day before election may be received until seven days after the election (September 19th). 8-412
- Sept. 13** **PRIMARY ELECTION DAY - Polls open 12 noon until 9PM**
(St. Lawrence County)
- Oct. 12** Applications for registration for the General Election by mail must be postmarked not later than this day. 5-210(3)
- Oct. 12** Last day to receive change of party enrollment. 5-304(3)
- Oct. 17** Last day for “Change of Address” to reach the Board of Elections to be effective for the General Election. 5-208.3

- Oct. 25** Board of Elections office will remain open until 7PM for the purpose of issuing absentee ballots. 3-214(3)
- Oct. 27 (Saturday)** Board of Elections office will be open 9AM-noon for the purpose of issuing absentee ballots. 3-214(3)
- Oct. 30** Last day to apply by mail for absentee ballot for General Election. 8-400(2)
- Oct. 30** Board of Elections office will remain open until 7PM for the purpose of issuing absentee ballots. 3-214(3)
- Nov. 1** Board of Elections office will remain open until 7PM for the purpose of issuing absentee ballots. 3-214(3)
- Nov. 3 (Saturday)** Board of Elections office will be open 9AM-noon for the purpose of issuing absentee ballots. 3-214(3)
- Nov. 5** Last day to deliver absentee ballot application or apply in person for an absentee ballot for the General Election. 8-200(4c)
- Nov. 6** Absentee ballots must reach the Board of Elections by the close of the polls on Election Day, except the ballots postmarked by the postal service not later than the day before election, may be received until seven days after the election (November 13th Military November 19th)
- Nov. 6** **GENERAL ELECTION DAY- Polls open 6AM to 9PM**
